



CARE INSTRUCTIONS MY HIVE WORKSTATION

To preserve the fabric color and appearance of the fabric, My Hive should be vacuumed regularly with a soft nozzle.

Polyester Stain Removal: Use uncolored paper towel or cloth to soak up as much as possible of the stain. Dried stains should be vacuumed. Moisten the stain lightly with a clean white cotton cloth, lukewarm water and possibly a small amount of pH-neutral detergent. Press a dry cloth or uncolored paper towel against the fabric so that moisture and dirt are absorbed. Repeat moisten and soaking until the stain is gone. Use clean water without detergent at the last moistening. Finish with soaking.

Wool Stain Removal: Dab or wipe gently with a moist cloth.
